**WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT FOR SMITH LAKE PARK FISHING TOURNAMENT WARNING: READ CAREFULLY. THIS AGREEMENT INCLUDES A WAIVER OF LEGAL RIGHTS AND RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT AND DEPRIVES YOU OF THE RIGHT TO SUE CULLMAN COUNTY AND OTHER PARTIES. DO NOT SIGN THIS AGREEMENT UNLESS YOU HAVE READ IT IN ITS ENTIRETY. SEEK THE ADVICE OF LEGAL COUNSEL IF YOU ARE UNSURE OF ITS CONSEQUENCE. IN CONSIDERATION of Cullman County, allowing me to participate in the Smith Lake Park Fishing Tournament, hereinafter referred to as "Tournament", I, for myself, and on behalf of my spouse, children, parents, guardians, heirs, and next of kin, and any legal and personal representative, executors, administrators, successors, and assigns, do hereby agree to and make the following contractual representations pursuant to this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement, hereinafter referred to as "Agreement".**

1. I hereby represent that (i) I am in good health and in proper physical condition to participate in the activities in which the Tournament provides; and (ii) I am not under the influence of alcohol or any illicit or prescription drugs which would in any way impair my ability to safely participate in Tournament; (iii) I have not been advised against activities by a health professional. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in activities.

2. I understand and acknowledge the physical and mental rigors associated with the activities in which the Tournament provides and realize that such activities are inherently dangerous and represent an extreme test of a person's physical and mental limits. I understand that participation involves risks and dangers which include, without limitation the potential for serious bodily injury, sickness and disease,

permanent disability, paralysis and loss of life; loss of or damage to equipment / property; exposure to extreme conditions and circumstances; accidents, contact or collision with others, spectators, vehicles or other natural or manmade objects; dangers arising from adverse weather conditions; imperfect water conditions; water, road and surface hazards; equipment failure, in adequate safety measures; participants of varying skill levels; situation beyond the immediate control of the Tournament; and other undefined risks and dangers which may not be readily foreseeable or are presently unknown. I understand that these Risks may be caused in whole or in part by my own actions or inactions, the actions or inactions of others participating in activities, or the actions or inactions or negligence of the Released Parties defined below, and I hereby expressly assume all such Risks and responsibility for any damage, liabilities, losses or expenses which I incur as a result of my participation in activities.

3. I agree to be familiar with and to abide by the Rules, Regulations, and laws established which include without limitation the rules of operation and warning guidelines of equipment used in said Tournament, Tournament rules and warnings, and local, state, and federal laws. I also accept sole responsibility for my own conduct and actions while participating in the activities, and the condition and adequacy of my equipment.

4. I hereby grant full permission to Cullman County and/or any and all agents authorized by them to use any photographs, videotapes, motion pictures, recording and any other record of activity or events for any legitimate purpose.

5. I hereby Release, Waive, and Covenant Not to Sue, and further agree to Indemnify, Defend and Hold Harmless the following parties: Cullman County, Cullman County of Commission, their Insurers, Promoters, Tournament Directors, Sponsors, Advertisers, Law Enforcement, Agencies and other Public Entities providing support for the activities, and each of their respective parent, subsidiary and affiliated companies, officers, directors, partners, shareholders,

members, agents, employees, representatives, and volunteers (Individually and Collectively, the "Released Parties"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss or expense (including court costs and attorney's fees) of any kind or nature ("Liability") which may rise out of, or relate to my participation in the activities, including claims for Liability caused in whole or in part by the negligence of the Released Parties. I further agree that if, despite the Agreement, I, or anyone on my behalf, makes a claim for Liability against any of the released Parties, I will indemnify defend and hold harmless each of the Released Parties from any such Liability which any may be incurred as a result of such claim.

6. I hereby warrant that I have read this Agreement carefully, understand its terms and conditions, acknowledge that I will be giving up substantial legal rights by signing it (including the rights of the minor, my spouse, children, parents, guardians, heirs and next of kin, and an legal and personal representatives, executors, administrators, successor and assigns), acknowledge that I have signed this Agreement freely and voluntarily with our any inducement, assurance or guarantee, and intend for my signature to serve as confirmation of my complete and unconditional acceptance of the terms, conditions parties regarding issues and no oral representations, statements or inducement have been made apart from this Agreement. My signature is relied on by the Released Parties for the engagement in the Tournament. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall e deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions. This Agreement is intended to be as broad as Alabama laws allow.
